1st place Guaranty \$2,500 on minimum of 25 boats LONG LAKE 1st place Guaranty \$1,500 on minimum of 30 boats PEWAUKEE LAKE General rules will apply as defined below, any changes will be announced at the Pre-Tournament Meeting

- 1. RULES: The following rules apply to these tournaments, special rules may apply at individual tournaments as may be dictated by the DNR or other controlling circumstances. Interpretation of these rules and final decisions will be left exclusively to the Lunker's Tournament Rules Committee.
- 2. PARTICIPATION & ELIGIBILITY: Participation in this tournament is open only to individuals who are 16 year of age or older with parental signature required to age of 18. The Tournament Committee reserves the right to reject any application that does not meet with the qualifying rules. Contestants will enter and fish as a team, single contestants will be treated as a team but are subject to bag limits as provided by state regulations for a single person.
- 3. ENTRANCE FEES: As defined on each entry form and must accompany the form to validate the entry. Receipt of a valid entry will determine "Order of Start". Entries accepted on the day of the tournament will be \$110 for Pewaukee Lake, and \$210 for Long Lake-cash only. All fees are final and non-refundable.
- 4. PRE-TOURNAMENT PRACTICE: As defined on each entry form TOURNAMENT WATERS are off limits Sunday at 11:59 PM prior to each Tournament Date.
- 5. REGISTRATION: Each competitor must register in person at the tournament headquarters by 6:30AM on the tournament day. There will be a pre-tournament meeting at 6:30AM, boaters and non-boaters are required to be present.
- 6. SPORTSMANSHIP: All of our competitors are expected to maintain the highest standards of sportsmanship, courtesy, safety, and conservation. Tournament fishing is a privilege that we ourselves will in large determine as to how it will survive in the future. Respect for the property owners, their boats, and other boaters is critical as to how we are viewed by the community. Any infraction of these basic sporting rules can be subject for disqualification at the judgement of a tournament official.

NO ALCOHOLIC BEVERAGES, OR NON- PRESCRIPTION DRUGS, OR OTHER STIMULANTS ARE ALLOWED IN THE BOATS AT ANY TIME DURING THE TOURNAMENT HOURS, this will be grounds for immediate disqualification.

- 7. SAFETY: All boats must be within compliance of all state and local municipality rules, and Lunker's Officers, or any tournament official, is not responsible, or to be held liable in any manner for citations that you may receive during the tournament. Each competitor is required to wear a securely fastened Coast Guard approved chest type life preserver any time the combustion engine is operating. Violation of this rule will result in immediate disqualification if observed by a tournament official. Kill switches if installed should be used.
- 8. TACKLE AND EQUIPMENT: Each contestant may use only one rod and one lure at a time. You may however have as many rods rigged and at your disposal as you wish. "ONLY" artificial lures may be used and Motor and Back Trolling with a combustion engine are prohibited.
- 9. BOAT, MOTOR, & HORSEPOWER RATING: Horsepower limitations are set by the US Coast Guard and each boat must not exceed the horsepower as identified on the attached rating plate. All boats must carry and adequately display and use equipment as so defined in the Wisconsin Boating and Wisconsin Fishing Rules. It is recommended that a livewell, fixed or portable be used so no injury to the fish is incurred through improper ventilation, or handling. An electric trolling motor may be used to position your boat.
- 10. BOAT REGISTRATION & INSPECTION: Each boat must have an identification number and that number match the number entered on the entry form. If you change boats between time of mailing your entry and the tournament, you must advise the tournament official at time of registration. Each boat will have a live well check and inspection prior to the tournament start. Each boater will receive a numbered paddle at registration identifying the position for "takeoff". It will be defined in the pretournament meeting both where the paddles will be collected, and what mark you must idle to prior to increasing from an idle speed.
- 11. PERMITTED FISHING LOCATIONS: Fishing will be confined to the tournament lake assigned each tournament. Special upstream or downstream, or other restrictions will be defined at the pre-tournament meeting. There is a 50 yard provision for anchored boats where no competitor other than the anchored boat is permitted. (Anchored boat, means a physical anchor with line is lowered to the bottom, having only the trolling motor down does not qualify). However, common courtesy would be to give a boat running on electric power sufficient space. Contestants must stay in the boat for the entire tournament day with the only place of departure being the tournament headquarters in the case of an emergency, or if an early weigh-in is defined at the pre-tournament meeting. In an emergency an appropriate tournament official must be notified of the condition causing the emergency as soon as possible.. Contestants cannot depart their boat to fish or to land a fish for any reason. However, a contestant may depart their boat to retrieve a fouled lure from a pier, boat/pontoon, or other personal property associated with a waterfront landowner.
- 12. SCORING: Only Largemouth and Smallmouth Bass will be weighed. A tournament limit of (7) bass in aggregate per team shall apply, and only that amount can be brought to the weigh station. At no time shall a competitor have in his possession more than the limits so described by state regulations. In all (3) tournaments bass as described which measure 14" with mouth closed, tail pinched, shall qualify. There will be no live release points. There will be a 6oz, deduction for each legal dead fish registered for total weight. This does not apply to big bass for the big bass pot.

ANY SHORT DEAD FISH WILL BE IMMEDIATE DISOUALIFICATION OF THE TEAM. ANY SHORT LIVE FISH will not count and will result in a 16OZ deduction of total weight, and the contestant will be subject to the discretion of a DNR official should one be present.

13. TIE BREAKERS: 1) Most legal Bass registered, 2) Most legal Bass registered alive 3) Combine and equally split 1st and 2nd prize money with coin toss for trophies, 4) All other ties split prize money. Decision of the tournament officials is final.

14. LATE PENALTY: LATE IS LATE if you are not within 100 feet of the pier, at tournament headquarters, at the ending time you are late AND ARE DISQUALIFIED. NO EXCEPTIONS.

15. None of the above rules shall prohibit a properly designated Tournament Official OR Tournament Director from approaching or boarding any competitor's boat at any time during the competition day.
